In 2000, the California Assembly Bill (AB) 1820 was signed into law. The bill requires general internists and family physicians whose patient population consists of 25% or more patients at least 65 years of age to complete at least 20 percent of their mandatory CME, or 10 CME hours for every two years of CME reporting, in the field of geriatric medicine.
